Dear Artisan,

You are invited to apply for the 38th annual "A Country Christmas Arts & Craft Show" to be held on October 27 & 28, 2012 at Crystal Lake South High School located at 1200 S McHenry Ave, Crystal Lake, Illinois. The show hours are 8:30 am to 4:00 pm on Saturday and 9:00 am to 3:00 pm on Sunday. Concessions will be available each day. Show fees benefit CLS High School Boosters. Each exhibitor retains his/her profits.

The show is the most widely attended and most anticipated show in the area. Extensive advertising is done through Chicagoland & Northwest area newspapers, local radio, billboards, yard signs, posters, flyers and mailing to previous customers.

The show is re-juried each year by appearance & craft and we accept a limited number of exhibitors in each category. Space sizes vary, but each exhibitor is guaranteed a minimum of 80 square feet with additional space available at half or full size for an additional fee. A non-refundable show fee must be submitted with your application. In the event of non-acceptance, the fee will be returned. Surge protectors are required for all spaces with electricity. Tables must be covered to the floor on all sides. Table rental is not available. Chairs are provided for each space. *Each exhibitor is to contribute an item from their inventory with retail value of \$25 to be used for a fundraiser raffle by the school.*

Exhibitors may display only the items for which you were juried. You will be asked to remove any items that are outside of your category or not hand-made. Imports are not accepted.

Application for "A Country Christmas Arts & Craft Show" begins immediately for returning Artisans. Please complete the following:

- 1) Application and Agreement completed, signed & dated
- 2) Check (dated 5-1-2012) made payable to: *CLS Boosters*
- 3) Three pictures of your craft, one of your display and one of your work in progress
- 4) Mail completed application with check to:
